## VENDOR ELIGIBILITY

Open to individual artists and crafters presenting **original works** and to **farmers** selling produce, canned goods and baked goods. **Non-profit** organizations may sell baked goods or items being sold to raise money for their organization. This show will be **juried** to maintain balance and variety. A limited number of resale and commercial items of highest quality may be accepted. Bandera Business Association reserves the right to reject any display that is not in keeping with the examples submitted.

## REGISTRATION: PRE-PAY ONLY!!

*Vendors MUST Pre-Register and Pre-Pay to Participate.*

**Booth Fee: \$45** for 10x10 space OR if you reserve for 2 or more months, and pay for them in advance, the fee is only **\$35** per month

**All registration forms must be accompanied by photos or e-mailed photos, or a web address with photos.**

(Note: The photo requirement is **waived** if you are a returning vendor and have previously submitted photos of your work to Bandera Market Days.) **Deadline** for applications for each show is the **Wednesday prior** to the scheduled Saturday event. Make checks payable to the **Bandera Business Association**. Your check will not be cashed until you are accepted into the show. Notification will be by phone or e-mail. **In Addition to the Market Day Permit, a Bandera City Vendor Permit is required. You must have your City application and all required information delivered to Bandera City Hall NO LATER than 5pm on the Wednesday before the event. Any City fees must also be paid in advance.**
