Bandera Business Association reserves the right to reject any display that is not in keeping with the examples submitted.

## **REGISTRATION: PRE-PAY ONLY!!**

Vendors MUST Pre-Register and Pre-Pay to Participate.

**Booth Fee**: \$45 for 10x10 space OR if you reserve for 2 or more months, and pay for them in advance, the fee is only \$35 per month

All registration forms must be accompanied by photos or e-mailed photos, or a web address with photos. (Note: The photo requirement is <u>waived</u> if you are a returning vendor and have previously submitted photos of your work to Bandera Market Days.) Deadline for applications for each show is the <u>Wednesday prior</u> to the scheduled Saturday event. Make checks payable to the <u>Bandera Business Association</u>. Your check will not be cashed until you are accepted into the show. Notification will be by phone or e-mail. In <u>Addition</u> to the Market Day Permit, a <u>Bandera City Vendor Permit</u> is required. You must have your City application and all required information <u>delivered</u> to Bandera City Hall <u>NO LATER than 5pm on</u> the Wednesday before the event. Any City fees must also be paid in advance.
